2.	003	The Disposition Holder must only enter, occupy and use the Lands for the purpose* and activity as referred to as such on the first page of this Disposition.
3.	005	The term of this Disposition means the period of time commencing on the Effective Date and ending on the Expiry Date, unless otherwise changed in accordance with this Disposition (the "Term").
4.	009	The Disposition Holder must obtain federal, provincial, municipal, and other permits and approvals, as applicable, with respect to activities that may take place on the Lands.
5.	018	When a Disposition has been terminated, the Regulatory Body may cancel any associated dispositions.
6.	1047	The Disposition Holder must maintain all activities for proper drainage of surface water.
7.	1058	The Disposition Holder must remove all garbage and waste material from this site to the satisfaction of the Regulatory Body, in its sole discretion.
8.	1200	The Disposition Holder must manage all weeds as per the Weed Control Act.
9.	1257	The Disposition Holder must conduct all activity to prevent and control erosion* and sedimentation on or adjacent* to the Lands.
10.	1258	The Disposition Holder must install and maintain erosion control* measures.
11.	1271	The Disposition Holder must not use soil sterilants for any activities on the Lands.
12.	1301	The Disposition Holder must not interrupt natural drainage (including ephemeral and fens*), block water flow or alter the water table.
13.	1307	The Disposition Holder must ensure all crossings maintain fish passage* and are compliant with the departments Code of Practice under the Water Act, Water (Ministerial) Regulation.
14.	1310	The Disposition Holder must not deposit or place debris*, soil or other deleterious materials* into or through any watercourse* and/or waterbody*, or on the ice of any watercourse* and/or waterbody*.
15.	1311	The Disposition Holder must maintain the access including crossing structures, ditches and other installations to ensure proper drainage.
16.	1326	The Disposition Holder must use only existing road* or bridge* crossings to gain vehicular access across any watercourse*.
17.		The disposition holder must only conduct operational water hauling between 08:00 (8 am) and 17:00 (5 pm).

- 18. The disposition holder must not conduct water hauling activities between May 1 and June 15 of each year.

- 19. The disposition holder must ensure that the number of water hauling vehicles does not exceed a maximum of fifteen (15) units per day.

- 20. The disposition holder must ensure that the water hauling vehicles do not exceed 50 km/hour.
